4	Local hotel tax.	Local Government Act cap 243 (Amendment) (No.2)2008 and Public Health Act Cap 281/17	Paid by all visitors who visits Hotels, Guest houses, inns, Serviced apartments, Motels to use the rooms for accommodation purpose and in return money.

This also includes payments of dues by farmers and business community who deliver merchandise to the Markets. This is governed under the Markets act Cap 94.
6.	Advertising.	The Physical Planning Act 20106 and National Physical Planning Standards And Guidelines 2011. Local Government Act Cap 243	Permit to advertisement in the Municipality using billboards banners, signpost Liquid Crystal Displays, Neon lights and any other form of advertisement.

Park Fess	Local Governments Act Cap 243 (Amendment of the Fifth Schedule) 2020 <sup>17</sup>	There is charged annual park user fee on every taxicab, Light omnibus, medium omnibus, or heavy omnibus licensed as public vehicle loading or offloading passengers within Kira Municipal Council. Collected by URA and remitted to the consolidated Fund for Allocation by the Accountant General Levied as follows  i) A person operating a taxicab or Light omnibus within and outside the Municipality and shall pay Ugx, 840,000 per year.  ii) A person operating a taxicab or Light omnibus within the Municipality only and shall pay Ugx, 720,000 per year  iii) A person operating a medium omnibus or heavy omnibus shall pay Ugx, 2,400,000 per year

11.	Lock Up Fees.	Local Government Act Cap 243 Kira Municipal Council Charging Policy	Kira Municipality owns Lock ups in Kireka and Bweyogerere Trading Centres
12.	Occupation permit.	Building Control Act 2013.	After completing Building covenant as provided for in 9 above Ddepartment of physical planning issue an occupation permit that will enable the developer get a full-term lease of 49 years for residential or 99 years for commercial property/development.
13.	Penalties and fines.	Listed Instruments, Regulations and Guidelines.	These are payment made especially for not honouring Listed instruments Regulations, guidelines and acting contrary to law.
14.	Hoarding permit.	Building Control Act 2013.	Payments for permission to be allowed to hoard a premises for new Development/Construction or renovation.
15.	Vaccination Certificate.	Public Health Act Cap 2814	Payments for Vaccination against particular requested for treatment and very commonly used by travellers abroad.

18.	Medical Fitness Certificate.	Public Health Act Cap 281	Payments made in respect of fitness to serve the public in respect of management of hotels and eating places. The payments also apply to Management of Hairdressing.
